I acknowledge that my pet(s) is in all respects healthy and has received all required vaccinations and does not suffer from any illness or condition which could affect other pets or Fur and Feathers Pet Resort staff safety.

_____ **Initial with staff member**

I understand that Fur & Feathers does not accept aggressive pets. I acknowledge that my pet(s) has not shown tendencies towards other animals or people and that if my pet displays aggressive behavior, that for the safety and health of my pet and others, he/she will be isolated from other animals for the remainder of his/her stay with no offset or reduction in price. If we determine your pet is dangerous we will ask that your pet be picked up immediately.

_____ **Initial with staff member**

Sometimes even the most sociable and playful dogs will get into an altercation with another dog. Additionally, dogs play with their mouths open and use their paws frequently. Injuries are a rare occurrence and our staff is trained to intervene quickly and safely; however despite all precautions, a cut or laceration can happen in seconds. I acknowledge and understand that every pet reacts differently. I recognize that there is an inherent risk of illness or injury in any situation associated with a cage-free or social environment and that Fur and Feathers Pet Resort is not responsible for any veterinarian expenses incurred.

If your pet needs medical attention, we will make every effort to contact you. If we are unable to reach you or your emergency contact, we will take your pet to a qualified veterinarian and you will be responsible for any and all charges related to your pet's medical care.

If your pet requires a bland diet due to vomiting or diarrhea the cost of the special bland diet will be applied to your account.

_____ **Initial with staff member**

We make every effort to minimize exposure to Kennel Cough by rigorous cleaning/disinfecting protocols and adhering to strict vaccination guidelines. We ask that you refrain from taking your pet to public pet places such as dog parks, pet stores, etc 10 days prior to coming into our facility. Please be aware that the kennel cough vaccine is not 100% effective and by avoiding public places you are helping to minimize kennel cough exposure.

_____ **Initial with staff member**

Dogs can become destructive with their belongings when boarding. We will make every effort to remove personal items if this occurs, however, Fur and Feathers Pet Resort is not responsible for any belongings coming into the facility with your pet. We ask that you label all belongings prior to check in to assist us with making sure all of your items are returned upon checkout.

_____ **Initial with staff member**

I acknowledge that if my pet is boarding check out time is 1:00pm. If my pet remains beyond the designated check out time, I will be required to pay additional boarding fees.
